The Turkish occupation and its mercenaries still continue their brutal and immoral practices and crimes against the people of Afrin from looting, kidnapping, arbitrary arrests, burning of forest trees, demographic change and many other violations .

In this file we will present the most prominent violations committed by the Turkish occupation and its mercenaries from 1 to 15 January 2019 as follows:

First: kidnapping and taxation:

On 12/1/2019 the mercenaries "Sultan Sulaiman Shah" of the Turkish occupation kidnapping the civilians, "Ahmed Mohammed Kalo" and "Walid Mohammed Jojo" on charges of service in the compulsory recruitment of the Democratic Union Party.



- On January 14, 2019, the mercenaries of the Turkish occupation imposed a tax on the peoples of the village of Hikkha, which was called the Protection Tax. The tax is estimated to pay each family four tank of olive oil to the mercenaries.



Second: seizure and confiscation of property:

On 5/1/2019 unknown masked men stole three motorcycles belonging to "Ali Mustafa Hassan Radwan Hassan Ramzi" and third to a displaced Guta .

On 6/1/2019, the mercenaries of the "Sham Corps" of the Turkish occupation looted and stolen the property of civilians in the village of "Baia" of the area of Shirawa and the vicinity of the castle of Samaan and the village of Bsufan, and civilians whose property was stolen are:

Mohammed Amin Mesto

Ibo Sliman

Izzat Sliman

Arif Sliman

The "Hamzat" mercenaries of the Turkish occupation raided the town of Basouta and stormed the house of civilian Mohammed Ahmed Khader on the charge of hiding a car belonging to the citizen Rustam Ahmed from the residents of Satian village and then arrested him and seized his car and the civilian car Rustam Ahmad. The principal owner is assured.

On 14/1/2019, mercenaries "Ahrar al-Sharqiya" of the Turkish occupation raided the house of civil "Abdul Qadir" of the people of the village, "Gulaq" in the area of Gondrissa, and expelled his family and then seized his house on the pretext that ownership of the property registered in the name of his daughter based in Aleppo .



Third: Deforestation :

On 9/1/2019, residents in the village of Kharrabeh Sharan cut off 15 olive trees belonging to Dr. Ibrahim al-Khalil, as well as trees owned by Kadri Musalli - Rizan Bakr - Ibrahim Sheikh Manan of Khilbash family.

Fourth: resettlement and Demographic Changes:

On 14/1/2019 the mercenaries of the Turkish occupation settled 40 families of the families of the mercenaries "Nur al-Din al-Zanki" in the village of "Kila", accompanied by the resettlement of some people from the settlers looting the homes of the people .
